## **Commitment to achieving Net Zero**

Ackerman Pierce is committed to achieving Net Zero emissions by 2050

Ackerman Pierce commits to reducing scope 3 emissions (Employee commuting) by 15% by 2027.

## **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

We have chosen the baseline year from September 2021 to September 2022 to initiate the benchmarking of our emissions for the first time. Given that this is our inaugural plan, some data is currently unavailable, but we are actively collecting it, and subsequent iterations of the plan will feature more accurate reporting.

### **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.'

We project that carbon emissions will decrease over the next five years to 31.1 tCO₂e by 2027.

This is a reduction of 15%

## **Carbon Reduction Projects**

In the future we hope to implement permanent measures such as:

- 100% paperless within 5 years reducing paper, electricity, ink usage
- Continue to employ staff within our local community.
- Promoting car share, other methods to get to work e.g. cycling, walking.
- Electric company car scheme give our employees the opportunity to drive hybrid/electric vehicles to commute to work to reduce our scope 3 7 emissions.

#### As an organization

- We are committed to supporting our local community, upskilling local people and employing locally. We hire apprentices in partnership with ACL (Adult Community Learning College) and trainees who receive extensive training on our mentorship programme.
- All our staff live within a maximum of 10 miles distance. So, the daily travel is lower than the average workplace. We are reducing this even further by:
  - Introducing company electric cars
  - Promoting local car share scheme/walking groups to get to work.
  - Providing vouchers to reduce the cost of bicycles being bought for travel to and from work.
- Internally all confidential documents are shredded and recycled, and we are aiming to be 100% paperless within 5 years reducing paper, electricity, hardware and ink usage.
- We recycle all printer cartridges and Waste Electrical and Electronic Equipment (W.E.E.E.)

#### **Local Economy**

Procuring goods and services locally where possible

- Ackerman Pierce is a small business who prefers when possible, to work with local companies supporting our communities and other small businesses.
- We have an active PSL for 90% of purchases we make as a business, which is only deviated from if it is extremely economically detrimental, or the service or product is not available from a local supplier.
- We have organised and lead litter picking initiatives.
